II) <u>Review of January 13, 2025 Meeting Minutes:</u> A first motion was made by Jim Foster to approve the WELCA minutes from the January 13, 2025 minutes. A second motion to approve the minutes with changes was made by Anthony Vigil. The minutes were approved as written (no changes) with a unanimous vote.

III<u>) January 13, 2025 Treasurer's Report:</u> (Jim Foster) WELCA Treasurer's report, dated from the February 3, 2025 meeting was approved as prepared and presented by Jim Foster

The November 12th, 2024 WELCA Treasury Report as follows:

- Savings Balance: \$9,017.49 includes \$ 0.13 interest in 2025
- Total Funds Available as of February 03, 2025 = \$9,209.91

Includes 341 paid members in 2024 out of 669 total members (112 members paid by Venmo)

Beginning Balance: 1/1/2025: = \$9,517.62

- Jim Foster reported that one dues check came in at \$30.00 which was the previous annual dues amount for several years before the recent dues increase. With the Newsletter/Dues letter going out soon, the WELCA Board took at wait and see if the same person will send in the additional \$10.00
- **Treasurer's Report Approved:** First motion made by Jim Foster to approve the Treasurer's Report. Jake Rapplean made a second motion to approve the Treasurer's report. The Treasurer's report was approved as written (no changes) with a unanimous vote
- IV) <u>WELCA 2025 Budget:</u> Jim Foster presented the proposed budget for 2025 is \$13,400. This is based on 335 Lochwood homeowners paying the \$40.00 annual dues. In 2024 a total of 341 (or approximately 51%) of Lochwood homeowners paid their dues. Remember WELCA Annual dues are voluntary. The Budget was tabled until the February meeting.
- Spring/Fall Clean-up Roll Off dumpster prices are \$450.00 /per dumpster (budgeted at \$2650 for spring, and (\$2000.00 for the fall) with 5280 Waste Solution which is a very good rate. Kaylee will look to see if any further discount rates for Roll Offs can be applied.
 - Newsletter costs printing costs are cheaper than last year, and WELCA purchased 1000 stamps for \$200.00 dollars. The first Newsletter will have a return envelope and voluntary dues letter.
 - Advertisements in our Newsletter 2 Advertisement so far trying to get more. Next Newsletter advertisement will be reduced to \$150.00 for 3 newsletters to 669 homes.
 - Addition to budgets is an item for banner signs for WELCA events.
 - Common Area Upkeep was cut from \$2000.00 to \$1500.00
 - Sign Repairs category was \$500.00 and was put under the WELCA Improvements
 - WELCA Door Prizes were also cut
 - Any budget shortfall could be met by cutting the fall clean-up session, cutting legal fees, cutting improvements, or decrease the number of newsletters.
- Final Budget was \$12,290 for 2025. Our current balance is \$9209.91

 The WELCA 2025 Budget was approved: First motion made by Jim Foster to approve the Annual Budget. Mary Carey made a second motion to approve the Annual Budget. The WELCA 2025 Annual Budget was approved as written (no changes) with a unanimous vote

V) Committee Reports

- Communication Committee The Communications Committee was the only committee to meet since the last WELCA Board meeting. The idea is to drive more activity to drive more people paying dues.
 - **Newsletter** Revamping the looks of our Newsletter and printing it in color and the printing was free. Paper will be 11" x 17" folded in half for 4 pages. Advertisement spots are being solicited and the Newsletter will be mailed by Valentine's Day.
 - An idea to have rotating spots in the Newsletter to drive interest such as a crime blotter, pet profiles, local sports, Veteran interviews, house of the month...etc.
 - Website the current website software is no longer supported by Register.com, and our website needs to be updated. Earl got a quote for 5 years cost but WELCA Board want a quote for 3 years support.
 - Try to add a dues payment portal to website to make paying dues easier. Link to Venmo or QR Code to pay dues.
 - Make a location where Lochwood residents can sign up for digital newsletter and capture email addresses to save on mailing costs.
 - Event Banners Have event banners printed up with QR code (\$85.00) per banner
 - Welcome Packages Becky Raish is developing this idea for new home owners to receive WELCA information and coupons from local business.
- **Clean-up Committee** Florida Avenue clean-up days, spring and late summer trash and leaves.
 - **Volunteers** regular meet to help with Common Area Maintenance for WELCA Entrance sign areas. Possibly use young adults in need of community volunteer hours.
- Covenants Committee Get the new WELCA Board volunteers on this committee up to speed on the covenants for each filing, what constitutes a covenant violation, the letter writing process, pictures, and tracking of new and ongoing violations.
- **Events Committee –** Planning the WELCA 2025 Events.
 - Easter Egg Hunt Held on Saturday April 19th preliminary planning
 - Create Signup Genius
